

SCHEDULED QUALIFIED FOOD OPERATOR COURSE OFFERINGS & EXAMINATIONS

The following offerings are intended for food workers seeking to fulfill the Qualified Food Operator requirement for Class III & IV food service establishments [CT Public Health Code Sections 19-13-B42(s)(4), 19-13-B48(j)(3), and 19-13-B49(t)(3)]. Currently there are only three exams that have been approved by the Department of Public Health to meet the QFO requirement, but these exams are offered by a number of consultants/organizations. (See page 2 for contact information for the 3 approved exam companies.) The schedule of exam offerings is not intended to be all-inclusive, as there may be other exam schedules that we have not received. Individuals interested in a QFO exam should inquire as to which exam is used to ensure it is one of the 3 approved exams. It may be helpful to call your local health department as many offer the approved exams and training themselves.
