This position is responsible for the maintenance, testing and expansion of the Emergency Notification System.

PREFERRED SKILLS:

- Experience, or familiarity with, computer programs such as EVERBRIDGE,WEBEOC, Maven (Local Health Management System), or other emergency operations computer programs;
- Experience with emergency communications, such as Health Alert Network Administrator (HAN) including familiarity with maintenance and development of HAN components and providing technical assistance; experience coordinating and collaborating with outside staff in reference to emergency preparedness;
- Experience in providing user training, and report generation;
- Experience in maintaining and updating directories of health alert network partners;
- Experience in overall public health preparedness response activities;
- Familiarity and/or training with Incident Command System.

MINIMUM QUALIFICATIONS REQUIRED

Knowledge, Skill and Ability: Knowledge of purposes, plans, objectives and programs of public health agencies including the changing patterns of preventive medicine and environmental health; knowledge of state and community organizations and programs involved in health field; considerable oral and written communication skills; interpersonal skills; ability to conduct independent research, develop and gather data.

EXPERIENCE AND TRAINING

General Experience: Five (5) years experience in a professional capacity in a health organization. A health organization is defined as a large multi-dimensional agency with responsibility for administering health programs.

Substitutions Allowed: 1.) College training may be substituted for the General Experience on the basis of fifteen (15) semester hours equaling one half (1/2) year of experience to a maximum of four (4) years for a Bachelor's degree. (1/2) year of experience to a maximum of four (4) years for a Bachelor's degree. 2.) A Master's degree in public health, health education, hospital administration or public administration or other closely related field might be substituted for the General Experience. 3.) For State employees three (3) years as a Health Services Worker may be substituted for the General Experience.

Special Requirements: Incumbents in this class may be required to travel.
