RESPONSE TO PETITION OF MANDELL & BLAU, M.D.'s, P.C.

On October 9, 2007, the Office of Health Care Access ("OHCA") denied the Certificate of Need ("CON") application of Mandell & Blau, M.D.'s, P.C. ("Applicant") under Docket Number 07-30929-CON for the acquisition of a 1.5 Tesla magnetic resonance imaging scanner ("MRI") and a 16-slice computed tomography ("CT") scanner to be located in a new radiology office in Blue Back Square in West Hartford, Connecticut pursuant to Section 19a-639 of the Connecticut General Statutes ("C.G.S."). On October 19, 2007, the Applicant filed a Petition requesting that OHCA reconsider the above decision for the MRI scanner only.

After careful consideration, OHCA has decided to not reconsider its final decision rendered on October 9, 2007, under Docket Number 07-30929-CON. The Applicant must file a new Letter of Intent with OHCA if it wishes to proceed with a proposal for the acquisition of an magnetic resonance imaging scanner or a computed tomography scanner at Blue Back Square in West Hartford, Connecticut.
