Dear Hospital Administrators:

Pursuant to Section 13(1)(1) of Public Act 15-146, each hospital and health system shall report no later than July 1, 2016, and annually thereafter to the Commissioner of Public Health concerning facility fees charged or billed during the preceding calendar year. The first filing in this regard will involve fees charged during Calendar Year 2015. These are for Outpatient

Services provided in Off-Campus locations. This section of this Public Act states:

Each hospital and health system shall report not later than July 1, 2016, and annually thereafter to the Commissioner of Public Health concerning facility fees charged or billed during the preceding calendar year. Such report shall include (A) the name and location of each facility owned or operated by the hospital or health system that provides services for which a facility fee is charged or billed, (B) the number of patient visits at each such facility for which a facility fee was charged or billed, (C) the number, total amount and range of allowable facility fees paid at each such facility by Medicare, Medicaid or under private insurance policies, (D) for each facility, the total amount of revenue received by the hospital or health system derived from facility fees, (E) the total amount of revenue received by the hospital or health system from all facilities derived from facility fees, (F) a description of the ten procedures or services that generated the greatest amount of facility fee revenue and, for each such procedure or service, the total amount of revenue received by the hospital or health system derived from facility fees, and (G) the top ten procedures for which facility fees are charged based on patient volume. For purposes of this subsection, "facility" means a hospital-based facility that is located outside a hospital campus. (see <https://www.cga.ct.gov/2015/ACT/PA/2015PA-00146-R00SB-00811-PA.htm>)

If you do **not** charge/bill any facility fees for outpatient services at locations outside of your hospital campus, please send an email to OHCA@ct.gov indicating as such.
