Dr. Rissi made a motion, seconded by Dr. Katz, to adopt the Consent Order. The motion passed unanimously. Ms. Emmett signed the Order which imposes a reprimand and a \$2500.00 civil penalty.

B. Stuart Steinman, MD – Petition No. 2014-927

Staff Attorney Linda Fazzina, Department of Public Health, presented a Consent Order in this matter. Attorney Robert Silva was present on behalf of Dr. Steinman.

Dr. Zeman made a motion, seconded by Ms. Jacklin, to adopt the Consent Order. The motion passed unanimously. Ms. Emmett signed the Order which imposes a reprimand, a \$3000.00 civil penalty and a six month period of probation.

C. Mark Thimineur, MD – Petition No. 2013-312

Staff Attorney David Tilles, Department of Public Health, presented a Consent Order in this matter. Attorney Ilyssa Kelson was present on behalf of Dr. Thimineur.

Dr. Rissi made a motion, seconded by Dr. Katz, to adopt the Consent Order. The motion passed unanimously. Ms. Emmett signed the Order which imposes a reprimand and a \$7500.00 civil penalty.
