Ms. O'Neill called the meeting to order at 9:03 a.m.

**I. Minutes – August 28, 2013**

Dr. Londono made a motion, seconded by Mr. Bernhard, to approve the minutes. The motion passed unanimously.

**II. Department Of Public Health Updates**

**A. Investigations Update**

Gary Griffin, Investigations Supervisor, Department of Public Health (DPH) reported that there are currently 13 veterinary cases under investigation by the DPH plus 3 cases involving unlicensed practice. 4 cases have been dismissed since the last meeting. 6 additional cases have been referred to the Department's Office of Licensure Regulation and Compliance for further review and/or action.

**III. Office of Licensure Regulation and Compliance**

**A. LuAnn Morgan (unlicensed) – Petition No. 2013-723**

Matthew Antonetti, Principal Attorney Department of Public Health, presented a Consent Order in this matter. Respondent was not present or represented.

Dr. Londono made a motion, seconded by Mr. Bernhard, to adopt the Consent Order. The motion passed unanimously.

Ms. O'Neill signed the Order in which respondent agrees to cease and desist the practice of veterinary medicine without first obtaining a license.

**A. Laurie Hollywood (unlicensed) – Petition No. 2011-1200**

Ellen Shanley, Staff Attorney Department of Public Health, presented a Consent Order in this matter. Respondent was not present or represented.

Dr. Cianciolo made a motion, seconded by Dr. Londono, to adopt the Consent Order. The motion passed unanimously.

Ms. O'Neill signed the Order in which respondent agrees to cease and desist the practice of veterinary medicine without first obtaining a license.

**IV. Other Business**

Mary J. Lis, DVM, State Veterinarian, Department of Agriculture addressed the Board asking if the Board could issue opinions regarding the micro-chipping of dogs and the use of diagnostic test kits by lay persons. Dr. Lis was advised that for the Board to address her concerns she would need to submit a request for Declaratory Rulings.
