- ❑ Analyze and/or modify State laws
- ❑ Develop policies and procedures
- ❑ Develop trust agreements such as data sharing, data use and reciprocal support agreements necessary to enable information exchange

The recommendations should also address how non-compliance with Federal and/or State law or policy applicable to HIE will be addressed.

This Committee is also charged with making recommendations regarding how the statewide HIE will comply with all applicable Federal and State legal and policy requirements, including how policy requirements will be developed and implemented to enable appropriate and secure HIE statewide as well as on an interstate basis.
