SUBJECT: Abbott, Mead Johnson, Nutricia and Vitaflo Formula Changes and Addition to Formulary

This memorandum provides both pertinent changes to the Connecticut WIC Formulary (WIC Special Formulas) and additions for the following manufacturers: Abbott, Mead Johnson, Nutricia and Vitaflo.

Abbott

Label Changes – Beginning April 2016

Size Change - Beginning as early as April 2016 going into July 2016

*The reconstituted ounces for the 12.1 oz can for Alimentum (powder) is 87 oz.

This product has been assigned a new UPC code and will have to be reset onto retailers’ shelves on the following dates provided by the company:

If your agency is still in SWIS, the checks are adjusted to reflect these changes as follows: ‘Similac Alimentum # cans 12.1 oz powder OR Similac Expert Care Alimentum # cans 16 oz powder’. The local agency nutrition staff shall explain the name and size changes of the products on the checks to the participant.

When the time comes for this change into CT WIC, please anticipate how many participants will be affected by this change by printing the “Formula Usage” report (falls under the Reports tab, scroll to Certification and select CERT 17.21). It is also recommended to provide visuals of the new label and size of Similac Alimentum Powder (see attached). Please reference to the Retailer Schedule (above) to see if the participant needs to continue with the old size or to postpone providing the new size until the retailers are ready and the product is available. Also the local agency WIC Nutritionists shall contact the retailer to verify what availability of the product in order to choose the correct one available prior to benefit issuance.

Mead Johnson

The 32 ounces RTU products discontinued by the manufacturer do not affect CT WIC formulary since they are not approved sizes.

Nutricia

In February 2016, Nutricia announced metabolic formulas to be discontinued and replaced with new and improved formulas effective immediately.
