Veh #1 was trav in the left and right lanes swerving between both. Veh #1 crossed into the left lane directly into the path of veh #2. The vehicles make contact and veh #1 goes into the center median (grass) where it rolls and strikes a large rock outcrop. Veh #2 continues north and comes to rest on the left shoulder. Operator #1 was transported to Hartford hospital by lifestar and was listed in stable condition. Accident is currently under investigation.

Connecticut State Troopers assigned to the State Police Traffic Services Unit (Truck Squad) who were assigned to participate in the Tri-State Commercial Motor Vehicle Road Check (RI / MA / CT) were en- route to their assignment for the day and traveling along I95 behind this accident scene. Upon their arrival to the scene these Troopers controlled traffic and diverted traffic from the accident scene as they reported this serious injury rollover accident and requested the assistance of Emergency Medical Services to the scene. Three of the Troopers (David Brigner, Matthew Feest and Jeffrey Krause) went to the assistance of the injured party in the rollover vehicle. The troopers observed that the victim was partially ejected from the vehicle and that the vehicle was resting on his upper torso preventing the victim from breathing. The Troopers were able to push, roll and hold the vehicle off of the victim and with the assistance of a paramedic who responded to the scene stabilize the victim until being treated by responding medical services and Life Star personnel.
