On 04/14/05, at approx. 6:30 p.m., troopers from the Troop D Quality of Life Task Force, with assistance from the Statewide Narcotics Task Force - East Office, the Brooklyn Resident Troopers' Office and the Killingly Resident Troopers' Office, executed a narcotics related search and seizure warrant at the above address. Seized from the residence was over 1/4 pound of marijuana, ready for sale, packaging materials, scales, assorted drug paraphernalia, and cash. The four below listed subjects were arrested in the apartment and charged with the below listed offenses. This search and seizure warrant was issued after troopers from the Troop D Quality of Life Task Force conducted an investigation into suspected narcotic sales occurring at this apartment.
