## **ARREST MADE IN OPERATORS LICENSE FRAUD CASE**

In July 2003 a complaint was filed with the Connecticut State Police alleging that Connecticut Operators Licences were being illegally obtained from the Norwalk Motor Vehicle Department. State Police Detectives conducted an extensive investigation into the allegation.

This year long investigation was conducted by Connecticut State Police Detectives with assistance from investigators in the Department of Motor Vehicles and the Norwalk State's Attorney Office. State Police investigators learned that these accused were working together to obtain fraudulent Connecticut Operators Licenses for subjects willing to pay \$1500 to \$3000. One accused employed at the Norwalk MVD worked with the other accused to obtain the illegal drivers licenses. As a result of information developed and evidence gathered during this investigation, State Police detectives submitted an arrest warrant application for 5 accused to Superior Court GA #20 in Norwalk. Five arrest warrant were issued by the court for the arrest of the accused in this case.
