BRIEF DESCRIPTION OF ACCIDENT

Veh#1 was traveling Southbound on Egypt Rd., Veh#1 went through the intersection of Egypt Rd. and Hoffman Rd striking a utility pole off the easterly side of the roadway. Veh#1 continued in a southerly direction rolling over coming to final rest on its roof in the northbound lane of Hoffman Rd. Op#1 was presumed deceased at the scene. Passenger #1 was transported by Life Star to Hartford Hospital for non-life threatening injuries. The accident remains under investigation.
