TFC Gary Perry #1340 was on-duty, seated in his patrol vehicle, parked on the shoulder of Route 66 Eastbound while investigating an accident during a period of freezing rain resulting in an ice-covered roadway. A vehicle being operated by Demont Highsmith (10/29/75) of Meriden was traveling Route 66 Eastbound when he lost control on the ice covered road, spun around, struck the rear of TFC Perry's vehicle, then continued rotating and the front end struck a pedestrian (Frank Pasca, 05/13/65 of Naugatuck) who was standing near the drivers side door of TFC Perry's vehicle. The pedestrian's leg was caught between the two vehicles causing it to break near the knee. TFC Perry was treated and released from Middlesex hospital for back pain.
