1. **Greg Peterson** (DOB:07/31/1988) of 81 East Ridge Rd. Middlebury, CT. for the crimes of Forgery 3rd and Larceny 6th
2. **Patrick Curley** (DOB: 09/23/1988) of 1097 Georges Hill Rd. Southbury, CT. for the crimes of Forgery 3rd, and Larceny 6th
3. **Kevin Scheer** (DOB: 07/01/1988) of 106 Luna Trail Southbury, CT for the crime of Forgery 3rd.
4. **Tyler Walsh** (DOB:05/10/1988) of 3 Westwood Dr. Middlebury, CT. for the crimes of Forgery 3rd, and Larceny 6th.
5. **Juvenile #1** (15 year old) of Middlebury, CT. for the crimes of Forgery 1st, Larceny 6th, and Conspiracy to Commit Larceny 6th.
6. **Juvenile #2** (15 year old) of Southbury, CT. for the crimes of Forgery 3rd, and Larceny 6th.
7. **Juvenile #3** (15 year old) of Southbury, CT. for the crimes of Conspiracy to Commit Larceny 6th, and Forgery 3rd.

Over the period of 02/26/05 and 02/27/05, Officer Grillo and the Southbury Police served seven arrest warrants on adults and juveniles that stemmed from a counterfeiting incident at Pomperaug High School between the dates of 02/08/05, and 02/11/05. All parties mentioned above voluntarily surrendered themselves after learning of the warrants for their arrests. The three juveniles were released on a written promise to appear, and are scheduled to appear in Waterbury Juvenile Court on 03/08/05. Peterson, Curley, Scheer, and Walsh were released on a court set written promise to appear and are scheduled to appear in Waterbury Superior Court on 03/09/05.
