BRIEF DESCRIPTION OF ACCIDENT

Tpr. Manuel Ramos was assigned to an HCP job on Rt. 7 in Norwalk. He was assisting the patrol by checking a hazardous disabled vehicle in the right lane on I-95 N/B just south of exit #16. Upon arrival Ct. reg. 620-FGN was stopped in the right lane and the operator (Dorothy Theilig, DOB 01/17/21) was attempting to start the vehicle. Vehicle #2 Ct. reg. 491-CRF was parked in the right lane behind the disabled vehicle. The operator (Diana Munoz, DOB 02/23/86) was about to help the elderly female in the disabled vehicle when Trooper Ramos arrived. Tpr. Ramos approached the vehicle and informed the operator that he would get a wrecker. The operator of the disabled vehicle opened the driver side door into traffic and attempted to get out in the roadway. Tpr. Ramos instructed the operator to get back into the vehicle for her safety. The operator of veh. #2 (Munoz) saw the trooper helping the disabled motorist and attempted to get back into traffic. Munoz was looking to the left at oncoming traffic in order to merge back in. Operator #2 did not see Tpr. Ramos in front of her vehicle and pulled forward into traffic striking Tpr. Ramos with the passenger side mirror knocking him to the ground. Tpr. Ramos was facing forward and did not see vehicle #2 coming. Tpr. Ramos was transported to Norwalk Hospital for minor injuries. WDTU assisted with sketch map. WDMC assisted with photographs of the scene. Tpr. Ramos was treated and released. Sgt. Anderson #203 Supervisor, MSGT. Peters #085 and Major Warren #010 on scene
