SUMMARY OF INCIDENT OR AFFIDAVIT: <input checked="" type="checkbox"/> ARREST MADE <input type="checkbox"/> UNDER INVESTIGATION That during the month of May 2005 troopers from the Troop D Quality of Life Task Force were investigating a Fugitive From Justice from the State of New York, troopers identified the below listed suspect (Epps) AKA; (Donaldson) living in the town of Pomfret. On 06/03/05 at approximately 8:30pm troopers from the Quality of Life Task Force, with assistance from the Statewide Narcotics Task Force - East Office, and the Killingly Resident Troopers' Office, located the aforementioned suspect traveling as a passenger in a vehicle in the town of Killingly. Subsequently vehicle was stopped on South Main St in Brooklyn and the suspect (Epps) was positively identified and was taken into custody without incident. Search of the vehicle resulted the seizure of approximately 2 ounces of "Crack" Cocaine pre-packaged, ready for sale, with a street value of approximately \$5000.00. Also arrested in the vehicle was the operator (Ciapocha), Subsequent investigation led to the search of the accused residence in Pomfret. Seized at that located was over 1 ounce of marijuana and \$1800.00 in cash.
