Vehicle #1 was travelling on I-95 Eastbound approaching exit 15. Vehicle #1 was in the left lane then suddenly swerved to the right, crossing the center and right lanes and striking the guardrail on the right shoulder. Vehicle #1 then moved back across the travel lanes and struck the median jersey barrier. Vehicle #1 came to uncontrolled final rest in the center lane. The deceased Adrian Mani DOB 9/8/82 was a passenger in the rear seat of the vehicle and was ejected through the rear window upon Vehicle #1's impact with the guardrail. A second rear seat passenger, Moises Mani DOB 7/1/82 was also ejected from the rear window of the vehicle but sustained lacerations and a minor head injury. This case remained open pending further investigation.
