BRIEF DESCRIPTION OF ACCIDENT

Vehicles 1 and 2 were picking up refuse on Skyline Dr, Salem. Both vehicles had stopped in the area of 16 Skyline Dr to pick up refuse and the occupants of both vehicles had exited the trucks. Both vehicles were stopped and veh 1 was behind veh 2. The pedestrian was at the rear of veh 2 when veh 1 started to roll forward. Veh 1 struck the rear of veh 2, pinning the pedestrian between the two trucks. The pedestrian suffered fatal injuries from being trapped between the 2 vehicles. The incident remains under investigation.
