NEWS RELEASE

On 03/25/04 members of Statewide Narcotics Task Force – Eastern Office, Ledyard Police conducted narcotics investigation in Ledyard involving the sale of Heroin. Information was obtained that a quantity of heroin was about to be delivered to a home in Ledyard. Officers intercepted the suspects as they approached 2 Woodview Drive. As result of the investigation, 380 bags of heroin, an additional 1/16 of an ounce of heroin and \$440 in cash was seized from the suspects. The narcotics seized have an approximate street value of \$8,000

NEWS RELEASE

On 03/25/04 members of Statewide Narcotics Task Force – Eastern Office, Ledyard Police and the Ledyard Resident Trooper executed a narcotics related search and seizure warrant at the home of Shawn Rainey and Michelle Cariglio located at 2 Woodview Drive in Ledyard. This search warrant was the result of a joint investigation of the Ledyard Police and SNTF. Located during the search of the home were 210 bags of heroin, approximately 30 Methadone tablets, and an assortment of approximately 300 controlled substance pills including Oxycontin. Additionally, \$11,000 in cash was also seized.
