On Thursday, May 27, 2004, at approximately 1537 hours, members of the State Police Troop K, DEA, Statewide Narcotics Task Force and the Willimantic police dept. executed a search and seizure warrant at 198 Brick Top road 2nd. floor in Windham, Ct. This search warrant resulted from a joint investigation into the sale of cocaine in the Windham / Willimantic area. A subsequent search of 198 Brick Top road yielded approximately 2 1/2 ounces of cocaine, packaged for resale and approximately \$2,300 in U.S. currency. The seizure resulted in the arrest of 2 persons for possession of narcotics with intent to sell 21a-278b and possession of narcotics 21a-279a and 1 person for possession of narcotics 21a-279a, as follows: Said individuals will be presented at G.A. 11 in Danielson on Friday, May 28, 2004 and held at Troop K in Colchester on a \$50,000 cash bond.
