## BRIEF DESCRIPTION OF ACCIDENT

Vehicle #1 while traveling east on RT6 in the area of Long Hill Rd in Andover CT was struck on its passenger side front by the front end and passenger side of vehicle #2, when vehicle #2 traveling west on RT6 crossed over the center line into the east bound lane. The rear of vehicle #2 then struck the driver side of vehicle #3. Vehicle #3 was parked on the right shoulder of the eastbound lane of RT6, in a construction pattern. The passenger of vehicle #2 was transported to Hartford Hospital by Life Star after a lengthy extrication. This accident is under investigation by the CT State Police.
