Summary of Incident or Affidavit: Arrest Made Under Investigation

On Tuesday, August 17, 2004 a representative of the Department of Children & Families discovered that one of their Exxon Mobil Credit Cards was missing / stolen and thousands of dollars worth of fuel and merchandise was charged on it. A subsequent investigation revealed that the credit card was taken at the beginning of March 2004 and that it was taken by the below accused who was an employee of the Department of Children & Families at that time. It was also determined that from the beginning of March 2004 to August 17, 2004, over \$21,142.00 worth of fuel and merchandise had been charged on the Department of Children & Families Exxon Mobil Credit Card. On 09-20-04 an arrest warrant was issued in the name of the below stated accused for the below stated charges by the States Attorneys Office in Hartford Superior, GA 14. On 09-21-04 the below accused turned herself in to Troop "H" in Hartford and was held on the \$50,000.0 Court Set Bond. The below accused was then transported to Hartford Superior Court, GA 14 for arraignment on 09-21-04.
