Vehicle #1 (a pickup and utility trailer) was stopped on the right shoulder of I-91 northbound north of exit 48 in Enfield for a motor vehicle violation by an on duty state trooper. Vehicle #2 was a Connecticut State Police cruiser stopped behind vehicle #1 with its emergency lights activated. Vehicle #3 was traveling northbound on I-91 in the left lane of three at a high rate of speed. As Vehicle #3 attempted to move from the left lane across all lanes to the right lane it traveled into the right shoulder and struck vehicle #2 which was pushed into vehicle #1. Vehicle #3 continued and sideswiped vehicle #1 and then rolled over coming to rest in the left lane. Vehicle #2 sustained severe damage and the trooper in the vehicle sustained fatal injuries. The operator of vehicle #1 was uninjured. The occupants of vehicle #3 sustained serious injuries and were transported to Baystate Medical Center. The collision is under investigation by the State Police Collision Analysis Reconstruction Squad and Central District Major Crime Squad.
