<p>The accused is the husband of the complainant, who is a schoolteacher at the Killingworth Elementary School. Communication between the complainant and accused led us to believe that there was the potential for violence between the two parties. As a result of this, the school administration placed the school in an administrative lock down to prevent anyone from entering the school. Once the accused was apprehended, the school was returned to normal status. At no point was any student or other person placed in any danger. The accused did turn himself in at Troop F in Westbrook upon learning that the Police were looking for him. He was charged with Breach Of Peace 53a-181a and released on a \$2500.00 bond. He will appear in Middletown Superior Court on 9/7/05. Victim showed signs of recent physical violence. No medical treatment was required.</p>
