****UPDATE—ARREST MADE****
MURDER/ROBBERY INVESTIGATION
THOMPSON, CT. THAT OCCURRED ON 09/07/05

On Sept.12, 2005 Arrest Warrants were issued in Danielson Superior Court for other individuals who were involved in the Robbery of Thomas O'Neil where he was subsequently murdered.

On September 12, 2005 at 8:19 PM hours, James A. Tetreault DOB: 04/16/1987 of 48 Plum Road Thompson, Ct. was arrested at his residence by Troopers from Troop D in Danielson, Ct. He was taken into custody without incident and held at Troop D on \$100000.00 cash bond pending arraignment in Danielson Superior Court on September 13, 2005. Tetreault was charged with Conspiracy to Commit Robbery 1st Degree.

On September 12, 2005 at approximately 10:00 PM Hours, the Massachusetts State Police Detectives assigned to the Worcester County and Essex County District Attorney's Offices and the Lawrence Ma. Police Department took into custody Michael Walsh DOB: 01/01/1988 of 715 Riverside Drive North Grosvenordale, Ct. as a Fugitive from Justice in Lawrence, Ma. Walsh was arrested by Massachusetts authorities as a Fugitive from Justice based on warrants issued out of the Windham County Superior Court for the crime of Conspiracy to Commit Robbery 1st Degree. Walsh was held in Massachusetts and will be presented in Lawrence District Court on September 13, 2005.

On September 13, 2005 at approximately 8:20 AM, Detectives from the Eastern District Major Crime Squad arrested a 15-year-old juvenile on an outstanding arrest warrant regarding this investigation. The juvenile was arrested in Thompson, Ct. for the charge of Conspiracy to Commit Robbery 1 St Degree regarding his involvement in this incident. He will be presented in Willimantic Juvenile Court on September 13, 2005.

The Connecticut State Police Major Crime Squad is still looking for information as to the whereabouts of Christopher Peltier W/M DOB: 08/08/1975. Peltier has outstanding warrants issued on him as part of this investigation for the crimes of Murder, Felony Murder, Robbery 1st Degree and Assault 2nd Degree. Peltier has several associates in Northeast Connecticut and Massachusetts.
