During the month of June, 2005, Colchester Police learned of a group of individuals who were allegedly selling crack cocaine in the Colchester and Hebron area. Statewide Narcotics Task Force was notified and a joint investigation was initiated. The investigation focused on crack cocaine sales in the two towns and identified several individuals who acted together in distributing crack cocaine in the area. Arrest warrants were obtained for those identified.

On 09/29/05 officers from Statewide Narcotics Task Force-East Office, Colchester Police, Colchester Resident Troopers Office, and the Hebron Resident Troopers Office located a motor vehicle that contained individuals for whom arrest warrants had been issued. As this vehicle pulled into a parking lot in the center of Hebron, officers approached. The car was found to contain five people, some of whom had arrest warrants issued for. A search of the car resulted in the seizure of 26.9 grams of crack cocaine, 5.5 grams of marijuana, over \$400 and assorted drug paraphernalia. All were transported to Troop K in Colchester and held on bonds (listed below) They are all scheduled to appear in GA19, Rockville on the court dates listed below.
