**INSTRUCTIONS**

1. Multiply the number of additional decal sets needed by \$10 to determine the amount due with this application.
2. Return this application with check or money order made payable to: COMMISSIONER OF REVENUE SERVICES.

**QUALIFIED MOTOR VEHICLES SUBJECT TO THE INTERNATIONAL FUEL TAX AGREEMENT ARE THOSE THAT ARE USED, DESIGNED OR MAINTAINED FOR TRANSPORTATION OF PERSONS OR PROPERTY AND:**

1. Have two axles and a gross vehicle weight or registered gross vehicle weight exceeding 26,000 pounds or 11,797 kilograms; or
2. Have three or more axles regardless of weight; or
3. Are used in combination, when the weight of such combination exceeds 26,000 pounds or 11,797 kilograms gross vehicle weight or registered gross vehicle weight.

**The term *qualified motor vehicle* does not include recreational vehicles.**

**1999 IFTA decals will not be released if you have any outstanding tax obligations.**

**SPECIAL INSTRUCTIONS**

1. **Change of Ownership:** If there has been a change of ownership or entity (partnership, new corporation, or an incorporation of previously unincorporated business), you must apply for a **new** Connecticut International Fuel Tax Agreement (IFTA) number. (Request Form CT-IFTA-2).
2. The taxpayer's address on this form must be the only address for all mail regarding the International Fuel Tax Agreement (IFTA). Do not use a tax preparer or a lessor of vehicles as a mailing address.
3. Attach a list of names and addresses of lessors who lease vehicles to you.
4. This application **must** be signed by owner, partner or corporate officer.
5. **All items on this form must be completed before decals will be issued.**

**IMPORTANT**
