APPLICATION FOR ADDITIONAL 2000 CONNECTICUT MOTOR CARRIER ROAD TAX DECALS

This application should be used only to order additional 2000 decals. It is not necessary to complete this application if you have already ordered all of the decals you need.

INSTRUCTIONS

- (1) Multiply the number of additional decal sets requested by \$10 to determine the amount due. Note: Each set contains two (2) decals.
- (2) Return this application with check or money order made payable to: COMMISSIONER OF REVENUE SERVICES.

NOTE: 2000 MOTOR CARRIER ROAD TAX DECALS WILL NOT BE RELEASED IF YOU HAVE ANY OUTSTANDING TAX OBLIGATIONS.

QUALIFIED MOTOR VEHICLES SUBJECT TO THE CONNECTICUT MOTOR CARRIER ROAD TAX ARE THOSE THAT ARE USED, DESIGNED OR MAINTAINED FOR TRANSPORTATION OF PERSONS OR PROPERTY AND:

1. Have two axles and a gross vehicle weight or registered gross vehicle weight exceeding 26,000 pounds or 11,797 kilograms; or
2. Have three or more axles regardless of weight; or
3. Are used in combination and the combined gross vehicle weight or registered gross vehicle weight exceeds 26,000 pounds or 11,797 kilograms.

Note: For Connecticut Motor Carrier Road Tax purposes the term *qualified motor vehicle* does not include recreational vehicles.

SPECIAL INSTRUCTIONS

- (1) **Change of Ownership:** If there has been a change of ownership, such as a new partner, incorporation, etc., you must apply for a **new** Connecticut Tax Registration Number. To apply for a new Connecticut Tax Registration Number, use **REG-3-MC**, *Application for Motor Carrier Road Tax*.
- (2) The address you list on this application must be the only address for all mail regarding the Connecticut Motor Carrier Road Tax. This must include all divisions of your company. Do not use a tax preparer or a lessor of vehicles as a mailing address.
- (3) Attach to this application a listing of names and addresses of lessors who lease vehicles to you.
- (4) This application **must** be signed by an owner, partner, corporate officer or LLC member.
- (5) Applications that are **not** completed properly or calculated correctly will be returned.

IMPORTANT

Do not use this motor carrier road tax application to request additional International Fuel Tax Agreement (IFTA) decals. To request additional IFTA decals, please complete **FORM CT-IFTA-2**, *Application for International Fuel Tax Agreement (IFTA) License Connecticut Carrier*.
