The total amount of tax due must be **paid in full**. If payment is not made on or before April 15, 2003, the tax due is subject to penalty and interest.

BALANCE DUE PAYMENT OPTIONS

A. Direct Payment: This option must be selected **prior** to the return transmission. You authorize the Department of Revenue Services to automatically withdraw the amount you owe, on the date you specify from your checking or savings account.

B. To pay by credit card:



- **By telephone:** Call Official Payments Corporation toll-free at **1-800-2PAY-TAX (1-800-272-9829)**.
- or
- **On-line:** Visit: **www.officialpayments.com**. Select Payment Center.

You will be asked to enter your zip code. A convenience fee will be charged by the credit card service provided. The fee is 2.5% of what you are paying. You may elect to cancel the transaction. At the completion of the transaction you will be given a confirmation number for your records.

Your payment is effective on the date the charge is made.
