



The contract between New Opportunities, Inc. ("Contractor") and the Connecticut Department of Social Services ("Agency") which was last executed by the parties on 11/24/2014 is hereby further amended as follows:

1. The total maximum amount payable under this contract shall be increased by \$124,409.00 from \$4,725,657.00 to \$4,850,066.00. This one-time increase is due to the various additions and/or reductions to FFY 15 and FFY 16 budget component revisions.
2. The budget on pages 2-3 of Amendment No. 1 is hereby deleted and shall be replaced in their entirety by pages 2-3 of this Amendment.

**All terms and conditions of the original Contract, and any subsequent amendments thereto, which were not modified by this Amendment remain in full force and effect.**






