HOW TO REGISTER FOR A PROVIDER FORUM

*HP now offers one method of Forum registration. To register for a Forum visit the www.ctdssmap.com Web Site and go to Information, then Publications and scroll down to Provider Forum Invitation Forms. Select the Forum and click on the Registration Link of your choice. **HP will not accept Forum registrations via email or telephone.***

Multiple attendees from the same provider office must register separately.

Once you click “Register Now” at the bottom of your registration page, you will be provided a Forum confirmation number. Please retain this number for your records should you need to discuss your registration with HP. If you do not receive a confirmation number, you have not successfully registered for this Forum.
