**Candidates must have applied for and passed the Electronic Technician 2 exam and be on the current certification list promulgated by the Department of Administrative Services for this classification. State employees currently holding the above title or those who have previously attained permanent status may apply for lateral transfer. Applicants will not have the opportunity to take the exam prior to the above closing date to qualify for this particular vacancy.**

The candidate chosen for this position will be held accountable for independently performing and supervising the full range of tasks associated with the installation, maintenance, repair and modification to electronic security systems and other electro-mechanical equipment and devices.

**Knowledge, Skills and Abilities:** Considerable knowledge of methods of maintenance, operations and repair of electronic equipment and devices; knowledge of Federal Communications Commission rules and regulations where applicable; knowledge of digital and logic functions; knowledge of integrated circuits including microprocessor units; ability to read and interpret instruction manuals and schematic and wiring diagrams; ability to locate and repair defects in electronic and electro-mechanical equipment and devices; knowledge of oscilloscope and signal generators; interpersonal skills; oral and written communication skills and computer skills;

**General Experience:** Four (4) years of General Experience in the maintenance, repair and servicing of electronic equipment.

**Substitution Allowed:** College training in electronics or related field may be substituted for two (2) years of the General Experience on the basis of fifteen (15) semester hours equaling one-half (1/2) year of experience to a maximum of two (2) years for an Associate's Degree.

**Special Requirement:** Incumbents will be required to possess appropriate current licenses, permits and or certifications. Incumbents will be required to attend technical seminars and classes. Incumbents will be required to travel.

**Character Requirement:** Candidates must be able to pass a military security clearance.
