Provide Funding for Assigned Counsel Rate Increases

Agency Description:

This expansion option includes rate increases for public defender assigned counsel. These include an increase of the criminal flat rate from \$350 to \$500 per case, which brings the flat rate compensation in line to what child protection attorneys are currently receiving. These rate increases also include an increase of the hourly rate from \$50/hour to \$60/hour for GAL and CP cases and an increase of the felony and appellate attorney's hourly rate to \$85/hour. A break-down of the rate increases are below:

Flat Rate Increase	\$	1,089,900

Criminal Hourly Increase	\$	997,601

It makes sense to have the compensation rates in line with the case demands and to ensure that the rates are as fair and equitable as possible. For example, if a client has a child protection case and a delinquency matter consolidated are paid a different rate for the same matter. In addition, it has been over six years since the hourly and flat rates have been increased for this work.
