The mentally ill offender often cycles through multiple criminal justice and public state agencies (e.g., Department of mental health; social services). Historically, once an offender enters the criminal justice system, there is little if any collaboration and communication between the various agencies prior to, during, or after the offender's incarceration. As a result, efforts to maintain continuity of mental health care, address criminogenic risks and needs, and effectively transition offenders back into the community are hindered. Using an interactive case study of a mentally ill offender, participants will learn the specific roles and interactions of the CT Department of Correction, Board of Pardons and Paroles, Correctional Mental Health Staff, Department of Mental Health and Addiction Services, Parole Field and Community Services, and Probation Department, working together to establish a continuous, seamless, case management transition plan using evidence based practices to inform treatment planning and supervision for community reentry.

This workshop will provide an overview of Court Support Services Division, the Board of Pardons and Paroles and the Department of Correction risk assessments tools that assist in guiding an offender throughout the criminal justice system. This workshop will give an overview of what risk assessment tools are being utilized as well as shared among the agencies. Overviews of the Level of Service Inventory Revised (LSI-R), Adult Substance Abuse User Survey Revised (ASUS-R), Treatment and Program Assessment Instrument (TPAI), and Connecticut Salient Factor Score (CT-SFS) will be given. These and other

tools that will be discussed are the tools used to transition an offender from the courts to the community and from incarceration to the community and back. These points of contact with an offender through these assessments provide essential information on the offender for enhancing public safety and reinforcing productive community membership.

Juvenile System: Raise-the-Age Transition Issues

Public Act 09-7 raised the age of juvenile jurisdiction in Connecticut from 16 years to 17 on January 1, 2010. The law makes many changes to the way all juvenile cases are handled. Because the Public Act did not include all offenses committed by 16 year olds, there has been some confusion surrounding the implementation. This workshop will include an overview of PA 09-7, a discussion of the challenges created by some sections of the legislation and an update on how implementation is proceeding.

Office of the Victim Advocate

The Office of the Victim Advocate (OVA), an independent state agency whose charge it is to identify gaps in services to crime victims and assist crime victims to ensure their voices is heard. The OVA responds to all crime victims throughout Connecticut. The OVA will present on the issues involving victim safety that often comes up in our daily work at the OVA and how the OVA can assist victims when their offender has been incarcerated and may be released. Other areas that will be covered are: the possibility early release options for inmates, victim participation in release decisions (ie. parole, and furlough) and how best to empower victims when faced with the pending release of an offender.
