

DIRECTIONS TO FOREST AND CAPITOL (LOT C)

VISITOR'S PARKING

Parking is available in designated PARKING LOTS **Forest and Capitol (Lot C)**. Please allow additional time to park and take the shuttle bus from the parking lot to 410-470 Capitol Avenue complex.

The Department of Public Works runs a fully accessible shuttle service (e.g., the bus has a hydraulic lift) that services the Capitol Avenue Complex, Oak and Capitol, and Forest and Capitol parking lots for the convenience of employees and visitors to the 410-474 Capitol Avenue Complex.

DIRECTIONS TO FOREST AND CAPITOL (LOT C)

From I-91 (north or south) and from east of the river


In Hartford, take I-84 west. Take Exit 46, Sisson Avenue. At the end of the exit ramp, turn left at the signal light onto Sisson Avenue. Take your first left onto Capitol Avenue. Take your first left onto Forest Street. The parking lot is on your left and is labeled "State of Connecticut." A shuttle bus to take you to our offices will either be waiting or will appear in a few minutes.

From the West

Take I-84 East to Exit 46, Sisson Avenue. At the end of the exit ramp, turn left at the light onto Sisson Avenue. Take your first left onto Capitol Avenue. Take your first left onto Forest Street. The parking lot is on your left and is labeled "State of Connecticut". A shuttle bus to take you to our offices will either be waiting or will appear in a few minutes.

From 410-474 Capitol Avenue

After exiting the complex make a right hand turn onto Capitol Avenue. Continue west on Capitol Avenue, making a right hand turn onto Forest Street. Parking Lot 'C' is located on the immediate left side of the street and is labeled "State of Connecticut".



The last building in the complex (470 Capitol Avenue) houses both the cafeteria and several conference rooms. This building is not accessible from the outside and visitors must check in with the security guard located in the first floor lobby at 450 Capitol Avenue. The security guard will direct visitors to the underground concourse that connects to 470 Capitol Avenue.

The Office of Policy and Management (OPM) announces that the examinations for Revaluation Personnel Certification will be held on **Thursday, March 27, 2014**. The following examinations will be offered:

-  Land/Residential
-  Commercial/Industrial
-  Personal Property
-  Supervisor

Time and Place

The examinations will be held at the Office of Policy and Management, 450 Capitol Avenue, Hartford, Connecticut. **The morning session examinations will begin at 8:30 AM and the afternoon session examinations will start at 1:00 PM.** Each examination session will last three (3) hours. All four examinations will be offered at both the morning and afternoon sessions. Please note that applicants are allowed to complete only one examination per session.

What to Bring

Persons taking the examination(s) will be required to produce photo identification prior to being admitted. A valid current drivers license is recommended. Silent battery operated calculators may be used during the examination. Cellular phones are not allowed.

Each applicant must complete and return an application form to the Office of Policy and Management postmarked no later than **March 13, 2014**.

Applicant Requirements

Admission to an examination will be allowed only if the applicant meets all the minimum experience requirements as stated within the “*The Regulations of Connecticut State Agencies*.”

Applicants for certification in *Residential Value Estimation* shall furnish documentary evidence of having not less than two (2) years of experience in the fields of assessing, revaluation or appraising.

Applicants for certification in *Commercial and Industrial Value Estimation* shall furnish documentary evidence of having not less than three (3) years of experience in the fields of assessing, revaluation or appraising.

Applicants for certification in *Personal Property Value Estimation* shall furnish documentary evidence of having not less than two (2) years of experience in the fields of assessing, revaluation or appraising.

Applicants for certification as a *Supervisor* shall furnish documentary evidence of having not less than three (3) years of experience in the fields of assessing, revaluation or appraising and of having received a passing grade for both the Residential Value Estimation examination and the Commercial and Industrial Value Estimation examination.
