State Energy Program purpose is to promote the adoption of energy efficiency and renewable energy technologies in the marketplace. As such, we have focused our program on multiple sectors. Those sectors include: Building Code training and compliance; Building Operator Training; Clean Cities program support; large commercial and industrial energy efficiency opportunities; small business energy efficiency opportunities, residential audits and efficiency opportunities; State building energy improvements, and incentives to promote the following kinds of installations on commercial and residential facilities: solar thermal systems, solar photovoltaic systems, geothermal heat pump systems; and fuel cell installations (commercial only). Piggybacking with existing program efforts in the state was a priority. Deliverables will include energy savings and greenhouse gas reductions. Progress will be measured on numbers of units completed, square footage of units completed, energy savings, and greenhouse gas reductions.

The following "deliverables" were provided this quarter: Number of solar thermal applications submitted and approved: 22; Home Energy Solutions: 1,298 households received services; State Building Energy Improvement Program: 2 facilities completed totaling 126,700 square feet; Building Operator training: 30 individuals completed the course; Clean Cities Coalition Support: The four Clean Cities Coalitions worked together to develop an alternative fuels educational & conference event in Hartford in October.


