The State Energy Program purpose is to promote the adoption of energy efficiency and renewable energy technologies in the marketplace. As such, we have focused our program on multiple sectors. Those sectors include: Building Code training and compliance; Building Operator Training; Clean Cities program support; large commercial and industrial energy efficiency opportunities; small business energy efficiency opportunities, residential audits and efficiency opportunities; State building energy improvements, and incentives to promote the following kinds of installations on commercial and residential facilities: solar thermal systems, solar photovoltaic systems, geothermal heat pump systems; and fuel cell installations (commercial only). Piggybacking with existing program efforts in the state was a priority. Deliverables will include energy savings and greenhouse gas reductions. Progress will be measured on numbers of units completed, square footage of units completed, energy savings, and greenhouse gas reductions.

 The following comments were provided this quarter: Number of solar thermal installations: 12 (7 this quarter); Number of geothermal heat pump installations: 101 representing 534 tons capacity (72 this quarter); Home Energy Solutions: 3,614 households received services (8,198,200 square feet); Solar photovoltaic: 2 projects at schools were submitted for approval; Fuel Cell Program: One project for a 400 kilowatt system has been approved, three other projects representing 2200 kilowatts are being prepared for review; State Building Energy Improvement Program: a total of 9 buildings, representing 911,000 square feet have been completed. Three projects are in the construction phase; Building Operator training: 29 individuals completed the level 2 course, Commercial Industrial Efficiency: projects completed at three buildings representing a total of 125,400 square feet; Clean Cities Coalition Support: The 4 Clean Cities Coalitions continued to work together to promote alternative fueling for transportation. Two fueling facilities (one Compressed Natural Gas (CNG) and the other a Liquefied Natural Gas/CNG combination fueling facility) were commissioned. The annual CT Clean Cities outreach event took place in October attracting 172 attendees; a baseline building code compliance survey will be completed next quarter. Four training classes were conducted with 85 total attendees. The
