II. Approval of the Minutes

A. Approval of the Minutes of the May 27, 2009 Special Meeting

Chairman Cashman called the meeting to order at 9:13A.M. Commissioners Jenkins, Gerratana and Bozzuto were present. Agency staff was also present.

Attorney Andrews requested the following item be added to the agenda, File No. 2009-045NF. It was moved by Commissioner Gerratana and seconded by Commissioner Jenkins to add this item as number 10 on the agenda. So voted.

Commissioner Cashman requested to add to the agenda a Resolution commending Commissioner Michael Dolan on the termination of his term. It was moved by Commissioner Bozzuto and seconded by Commissioner Gerratana to add the Resolution. So voted.

Commissioner Gerratana read the Resolution expressing the gratitude of the State Elections Enforcement Commission and staff to Father Michael Dolan for his dedicated service as a member of the Commission.

Ms. Zaccagnino gave a presentation on the Citizens' Election Program survey results that were administered to candidates, deputy treasurers and treasurers. Response rates and customer satisfaction expressed were very high.
