I. *Call to Order*

Chairman Anthony Castagno was present and called the meeting to order at 9:00 A.M. Commissioners Stephen Cashman and Patricia Stankevicius were present, agency staff was also present.

Commissioner Castagno called for a moment of silence to remember Commissioner Joan B. Jenkins. Commissioner Castagno said on behalf of the SEEC that Commissioner Jenkins will be sorely missed and he appreciated her service.

Commissioner Cashman said that she was an extraordinarily talented woman and touched the lives of many children. Through her service on the Elections Commission and Ethics Commission she did invaluable good. Joan gave great advice to him over the years as Vice-Chair of the SEEC. He regrets that Connecticut has suffered the loss of a remarkable public servant. We will miss her.




