

Grant Application Deadlines & Commission Meeting Dates for 2014 Statewide Office Elections

Pursuant to P.A. 11-48, weekly grant application deadlines fall on Wednesdays (except where a state holiday occurs) and the Commission has 10 business days to review statewide office applications and make a grant determination.

Primary Grant Applications Will Not Be Accepted After July 18 at 5 p.m.

*Note: During the “primary blackout period” (beginning after 5:00 p.m. on July 9 and through 5:00 p.m. on July 18) candidates not facing primary may still submit applications for general election grants, but the applications will be deemed as received for the July 23 application deadline, and the Commission will not make a grant determination on such general election applications until its August 6 meeting for statewide offices.
