I. *Call to Order*

Chairman Anthony Castagno was present and called the meeting to order at 9:04 A.M. Commissioners Stephen Penny and Salvatore Bramante were both present, agency staff was also present.

II. *Approval of the Minutes*

Approval of the Minutes of the Meeting of September 18, 2013

III. *Administrative Reports*

Mr. Brandi updated that with regard to personnel, SEEC received 497 applications for the Clerk Typist position. SEEC is in the process of trying to hire for this position and hoping to hire in the next few weeks.

Budget wise, the agency is on target. We are working with OGA and with our own fiscal crew to make sure that all of the needs of SEEC are met.

Our IT crew is doing a wonderful job with eCRIS and moving forward with our programs internally.

Our audit unit has been making diligent progress on the audits. We expect that within the next two months we should complete our audit process for the 2012 election as well as the remaining items from the statewide elections in 2010.

We have Municipal elections coming up, so our legal compliance unit has been busy answering questions with our elections officers and addressing multiple questions coming in from all over the state.

We are formulating our legislative agenda. We are not anticipating a lot of activity at the GAE. SEEC is focusing on four key items, the first, is the Citizens' Election Fund fix. SEEC is looking forward to future grant seasons to make sure that the fund has enough whether we increase the statutory funding that goes directly into

the account every year or whether SEEC adopts a form of overdraft protection. The second item is our municipal pilot program. SEEC was able to get the item passed through the House this past session, however ran out of time with the Senate. Another change we are looking to propose is a minor change to the method of the audit system and the need to fine tune it for all committees. If we can get the Committees to submit their bank statements it will allow us to make sure that all surpluses have been returned. What we'd like to do is obtain bank statements as the committees terminate to help them along and make sure that they have properly terminated. The fourth item on our agenda relates to Public Act 13-180 and was the change in part of disclosure and penalties that increased the fine and took out the criminal penalty. We are looking to still have the criminal penalty as part of the act.

Attorney Kief updated that SEEC has proposed Declaratory ruling 2013-01. SEEC has sent notice to all those who have requested it, are receiving comments and will bring those to next month's meeting along with suggested changes to the draft based on those comments.

SEEC has received one or more requests based on new law 13-180 and clarifications as to how it works for political committees versus those making independent expenditures.




