I. Call to Order

Chairman Castagno was present via teleconference and called the meeting to order at 9:02 A.M. Commissioner Stephen Cashman was present and Commissioners Patricia Stankevicius and Joan Jenkins were present via teleconference, agency staff was also present.

III. Administrative Reports

Mr. Brandi advised that budget talks are moving forward and that session has started. SEEC staff will be meeting the new chairs and GAE Committee today. There has been quite a bit of change of membership on the committee, so SEEC is looking to schedule as many meetings as possible and work with them on our legislative package. Items for legislative session include commissioner terms, prior bad acts and campaign finance law, a pilot program for municipal campaign finance filings and the sufficiency of the CEF.

Mr. Brandi reported that the next budget is where we want to be mindful regarding sweeps or reductions to the fund. We have about 13 million in the fund and if there are no further sweeps, SEEC will have 20 million by the end of this fiscal year.

Mr. Brandi updated that personnel wise, the Associates Account Examiner position has been filled. SEEC has promoted internally, Hy Ly to this position. Personnel Search Committee has been set up for the Legal Investigator position with more than 60 applications being received.
