failure to file the November 1, 2012 filings due to disruptions caused by Storm Sandy. It was moved by Commissioner Stankevicius and seconded by Commissioner Castagno to adopt said resolution. So voted.

IV. Administrative Reports

Mr. Brandi reported on the election day hotline updating that the SEEC handled 600 election related calls including some from other states as the SEEC's number was posted as a national hotline number. SEEC did have constant contact during the day with the Secretary of the State's office, the FBI and U.S. Attorney's office. SEEC was trying to track any issues nationwide that we should have been aware of. SEEC is expecting an upswing in enforcement matters as a result of election day activities and complaints.

Mr. Brandi advised the Commission that there are still four vacancies to be filled. The tests have been concluded through DAS for the Director of Disclosure and Audit as well as the Legal Investigator Position and SEEC is awaiting the next steps to the process. It is hoped to have these done by the first of the year.

Mr. Brandi updated the Commission that the audit lottery has been conducted successfully and campaign committees have been selected for audit.

Regarding construction on the first floor build out, SEEC is awaiting to see any further developments.


VII. Adjournment
