I. *Call to Order*

Commissioner Castagno was present and called the meeting to order at 9:04 A.M. Commissioners Salvatore Bramante, and Stephen Penny were present. Commissioner Patricia Stankevicius was present telephonically. Agency staff was also present. Commissioner Michael Ajello joined the meeting at 9:22 A.M.

II. *Approval of the Minutes*

III. *Administrative Reports*

Mr. Brandi reported that SEEC is in the process of reviewing the elements of the DGA lawsuit.

Mr. Brandi advised that the agency has been handling a multitude of calls. There are in excess of 240 candidate committees that have been formed and conversing regularly with commission staff.

Mr. Brandi updated that the audit unit has been doing a fantastic job with the PAR process which is the pre-application review process which SEEC implemented in the 2012 cycle. This allows candidates on certain time frames to submit their qualifying contributions allowing us to pre-qualify as many as possible prior to their coming in with their complete grant applications. This is a huge advantage which allows staff

more time to review what the applications will look like. To date SEEC has 81 submissions for pre-applications with 8 applications being qualified.

Mr. Brandi reported in terms of budget, we are in the fourth quarter and are analyzing all areas to determine final purchases at year end. Discussed larger IT purchases including a SANS server which will enable us to move into the next phases of eCRIS and ensure that we have enough storage in the future.

Mr. Brandi advised that SEEC has sufficient funding to get to the end of the year while making some purchases that will enhance our functions and operations.

Mr. Brandi updated that legislative session has now ended and senate bill 455, which was our main priority for the Commission was passed by both chambers and is just awaiting the Governor's signature. This was a critical bill that basically guarantees the payment of all grants. The bill allows us to use a money management technique which would allow us to draw from our back up sources and then replenish those sources once escheats come in.

Mr. Brandi reported that may 29th will begin the weekly meetings for CEP applications.


VII. Adjournment
