PROHIBITED RECIPIENTS LIST OF POLITICAL COMMITTEES
2009 REGULAR SESSION OF THE CONNECTICUT GENERAL ASSEMBLY

This list is issued by the Commission as required by the provisions of §9-610(f), General Statutes. It contains the name of each political action committee (PAC) which is *barred from receiving political contributions during the 2009 legislative session* from individuals who are registered lobbyists and those political committees which appear on the list entitled "*Political Committees Established by or On Behalf Of A Lobbyist.*"

The ban applies from the opening of the regular session on January 7, 2009 until adjournment sine die on June 3, 2009. Candidate and exploratory committees for statewide office and the General Assembly are also barred from receiving lobbyist contributions during the session, including those committees of candidates who ran in previous elections for such offices, and which have deficits. Statewide office refers to the offices of Governor, Lt. Governor, Secretary of the State, Treasurer, Comptroller and Attorney General.

In accordance with Section 9-610(f), General Statutes, any political committee established by two or more individuals is subject to these restrictions if its treasurer failed to certify to the Commission that it was "not established (a) for an assembly or senatorial district, (b) by an elected statewide official, a member of the General Assembly, or their agent, or (c) in consultation with or at the request or suggestion of any such official, member or their agent, or controlled by such official, member or agent." District committees are separated from the other political committees on this list for ease of identification.

This list has been distributed to each statewide officer and legislative leader enumerated in §9-610(f), General Statutes. It is also available on our website at the above address. Any supplemental list(s) of newly registered political committees, which are subject to these restrictions, will be similarly distributed.
