**I. *Call to Order***

Commissioner Castagno was present and called the meeting to order at 9:32 A.M. Commissioners Salvatore Bramante, Stephen Penny and Michael Ajello were present. Commissioner Patricia Stankevicius was present via teleconference. Agency staff was also present.

Commissioner Castagno added the Citizens' Election Program approvals to the Public Session and two audit reports to Executive Session.

**II. *Approval of the Minutes***

**III. *Administrative Reports***

Executive Director Brandi informed the commission that following the latest special session the agency budget for the current fiscal year has been reduced by a total of \$181,000. Because the majority of our annual budget covers personnel costs, this amounts to a 40% cut to our operating budget.

For a personnel update, Executive Director Brandi highlighted the recent retirement of a Lead Legal Investigator and the departure of the Clerk Typist. The agency now waits for action from the Department of Administrative Services to fill these open positions.

Today the commission will be looking at two grant applications for the February 2, 2016 special election in the 121<sup>st</sup> House district. There is \$14 million currently in the Citizen's Election Fund which will allow the agency to fully fund the grant program for the 2016 election cycle. 50 candidate committees have already filed their paperwork with the staff for the 2016 General Election.

Mr. Brandi provided the Commission with a general operations update. The agency is focused on training for newer staff and building backups within the agency staff

structure. Also, staff has prepared a legislative agenda for the Commissioners to review before we present it during the 2016 Legislative Session.
