**PROHIBITED RECIPIENTS LIST:
POLITICAL COMMITTEES PROHIBITED FROM RECEIVING LOBBYIST CONTRIBUTIONS
2013 SESSION OF THE CONNECTICUT GENERAL ASSEMBLY**

This list is issued by the Commission as required by the provisions of General Statutes § 9-610 (f). It contains the name of each political action committee (PAC) which is *barred from receiving political contributions during the 2013 legislative session* from individuals who are registered lobbyists and those political committees which appear on the list entitled "*Political Committees Established by or On Behalf Of a Lobbyist.*"

The ban applies from the opening of the regular session on January 9, 2013 until adjournment sine die on June 5, 2013. Candidate and exploratory committees for statewide office and the General Assembly are also barred from receiving lobbyist contributions during the session, including those committees of candidates who ran in previous elections for such offices and which have deficits. Statewide office refers to the offices of Governor, Lt. Governor, Secretary of the State, Treasurer, Comptroller and Attorney General. In accordance with General Statutes § 9-610 (f) any political committee established by two or more individuals is subject to these restrictions and included on this list if its treasurer failed to file a biennial registration statement by November 15, 2012.

This list has been distributed to each statewide officer and legislative leader enumerated in General Statutes § 9-610 (f). It is also available on our website at the above address. Any supplemental list(s) of newly registered political committees, which are subject to these restrictions, will be similarly distributed.
