for offices to be filled at the November 7, 2006 state election.

This list is compiled from official filings with this office, as of **November 3, 2006**

PARTY DESIGNATIONS.

Major Parties: R = Republican. D = Democratic.

Minor Parties for certain offices; and Party Designations used on Nominating Petitions: CC = Concerned Citizens. G = Green. I = Independent. L = Libertarian. REF = Reform. (More will be added as eligible minor-party nominations are filed and as nominating petitions are certified.) PC = Petitioning Candidate with no party designation. (WI = registered Write-In candidate)

NO CANDIDATE. (a) If only one major party's candidate for an office is listed and the other major party's designation (R or D) is not yet shown, the name of the "missing" party's candidate (if any) for that office has not yet been filed with the Secretary of the State. See "STD" and "Completion of List" below. (b) The term "*Vacancy in Nomination*" following a party's designation means that the party presently has no candidate for that office due to a nominee's withdrawal, but may nominate a replacement candidate. (c) The term "*No Nomination*" means that the party will have no nominee for that office at the election.

OFFICES OMITTED. The list will not include the following offices to be filled at the November 7 election: local offices to be filled in a few towns.

PRIMARIES. An August 8 primary for a major party's nomination for an office is indicated by the listing in **boldface** of two or more candidates with the same party designation for that office. In a primary the name of the party-endorsed candidate, if any, is designated by an asterisk (*).

COMPLETION OF LIST.

A. MAJOR PARTIES.

State and District ("multi-town") Office. Major-party candidates (including **primary** candidates) for *statewide and multi-town district* offices as well as single-town Assembly districts will be added to the list as their certifications are received. These *multi-town* major-party listings (both non-primary and primary) and single-town Assembly districts are complete.

Municipal ("single-town") Office. (1) Major-party **primary** candidates for municipal offices (including *single-town* Assembly Districts) will be added to the list as municipal Notices of Primary are received from Town Clerks. These *single-town* major-party **primary** listings are complete. (2) *Non-primaried* major-party nominees for municipal offices (excluding single-town Assembly) will be added as lists of such municipal nominations are filed by Town Clerks. These *single-town* major-party *non-primary* listings are complete.

Primary Results. Major-party candidates who lost in the August 8 primary have been removed from this list.

B. OTHER PARTIES AND CANDIDATES.

(1) Minor-party and nominating-petition candidacies for all offices will be added to the list as their nominations and petitions are filed and certified. These listings are complete. (2) Registered write-in candidates will be added as their write-in registrations are filed; these listings are complete.
