

**CHART OF PROPOSED VIOLATIONS AND PENALTIES
FOR LICENSED CONNECTICUT TEEN DRIVERS**

NOTE: THESE ARE NEW, MANDATORY SUSPENSION TERMS PROPOSED FOR TEEN DRIVERS WHO VIOLATE THE LAWS LISTED BELOW. CURRENT LAW (§14-50b) REQUIRES A \$125 LICENSE RESTORATION FEE BE PAID BY ANY DRIVER TO REINSTATE THEIR DRIVING PRIVILEGE AFTER SUSPENSION. THE INCREASE TO A \$250 RESTORATION FEE FOR TEENS CONVICTED OF A SECOND OR THIRD OFFENSES IS A NEW PROPOSAL. THE FINES NOTED ARE CURRENTLY OUTLINED EITHER IN STATUTE OR IN THE SCHEDULE PUBLISHED BY THE SUPERIOR COURT.

*** Add following offenses to trigger participation in DMV’s Operator’s Retraining Program: passenger restriction violations, use of cell phone or mobile electronic device while driving, and street racing. NOTE: If a driver under the age of 24 receives two of the violations listed below, they will be required to participate in the ORP.**

**** Section 14-36g(d) of the Connecticut General Statutes currently authorizes the Commissioner of the Department of Motor Vehicles to suspend the license of any person who commits a second or subsequent violation of the graduated licensing laws (passenger restrictions, curfew, etc.) until such driver attains the age of 18 years.**
