I. Call to Order

Commissioner Castagno was present and called the meeting to order at 9:12 A.M. Commissioners Salvatore Bramante, Stephen Penny and Michael Ajello were present. Agency staff was also present.

II. Approval of the Minutes

Approval of the Minutes of the Meeting of April 14, 2015

It was moved by Commissioner Bramante and seconded by Commissioner Penny to approve the Minutes of the April 14, 2015 regular meeting by a vote 4-0-0 vote.

III. Administrative Reports

Executive Director Brandi informed the Commission that the agency is entering the last month of the fiscal year and is looking to end the year with a budget surplus. The surplus is mostly attributed to personnel vacancies. Mr. Brandi noted that some of the surplus funds would be used to update and replace technology equipment since the state's CEPF funds were zeroed out in the bond process.

Mr. Brandi provided a legislative update to the Commission. The Commission is closely monitoring the progress on the State Budget and working with leadership to stress the importance of holding the line on the current figures allocated. The municipal pilot program (HB 6475) is languishing in the House of Representatives and the campaign finance bill (SB 1126) is hung up in the Senate. With only two weeks to go, and a considerable amount of business remaining, there is a high likelihood that the legislature will need to go into Special Session.

Mr. Brandi gave a personnel update to the Commission, highlighting Attorney Patrick Lamb's recent election as Chief Steward of the Administrative and Residual Employees Union. Attorney Lamb will be leaving the Commission for his new appointment in two weeks, and both Executive Director Brandi and the Commission members extended their gratitude for his service. The State Elections Enforcement Commission is nearly at the full complement of staff, minus Attorney Lamb's new assignment and the Information Technology Manager. Also, the various appointing authorities have been notified of their individual Commissioner term's expiration dates and need for reappointment.

Commissioner Bramante asked about how we are handling replacing Attorney Lamb. Executive Director Brandi is waiting to hear from Labor Relations.

Commissioner Bramante asked about the status of the computer seized by the Office of Governmental Accountability. Executive Director Brandi confirmed that the computer unit remains in the custody of the Chief State's Attorney and is currently under investigation by an independent forensics expert. The commission is working to resolve this matter as soon as possible and Executive Director Brandi hopes to have a report next month.

Chairman Castagno made the following statement on the record:
The Chair acknowledges receipt of communications from counsel for the Connecticut Democratic State Central Committee and the Dan Malloy for Governor Committee dated March 16, 2015 and March 26, 2015 and addressed to Executive Director Michael Brandi and Commission Chair Castagno, respectively. No action will be taken as to these items at this time.

The Commission has already made a determination as to its legal basis and authority to investigate here. On October 17, 2014 and pursuant to its authority in subsection (a) of Section 9-7b of the General Statutes, the Commission determined that it had sufficient authority to authorize an investigation into potential impermissible activity by, but not limited to, those

persons named in the complaint filed by Mr. Labriola.

As to the specific issues of federal election activity and preemption that are presented by the Respondent, the Chair notes that the Commission has already spoken on these issues on multiple occasions. Advisory Opinion # 2014-01, the Commission's statements in FEC Advisory Opinion 2014-16, and the Commission's recent response to Counsel for the Connecticut Democratic State Central Committee's request for a declaratory ruling last month are but a few examples.

Such substantive legal questions aside, the Chair hastens to point out that the matter is in the middle of an investigative process, not an adjudicative one. Indeed, the Commission made this point clear in its response to the request for the declaratory ruling last month.

To date, no charges have been brought by the Commission in the form a reason to believe finding. All persons' rights to contest any such charges and present legal arguments remain intact, but any such discussion is premature. No adjudicatory administrative proceeding has been brought against any person in relation to this matter. Indeed, none may ever be brought.

Importantly, the Commission lacks sufficient information to make such a determination on the allegations alone. The information gleaned from an agency investigation is crucial in making such a determination in any instance. This case is no different.

This matter is continued. The Chair leaves the staff to its investigation.




IX. Adjournment
